## COGNITIVE BEHAVIOUR THERAPY (CBT) THERAPIST **Ontario Structured Psychotherapy**

Job Status: 1.0 FTE Permanent

#### **Purpose of the Position:**

The Canadian Mental Health Association Muskoka-Parry Sound, is currently seeking one (1) CBT therapist for the Ontario Structured Psychotherapy – North Simcoe Muskoka Program. The purpose of this position is to provide cognitive behavioural therapy services to adults (18+) who are experiencing depression and/or anxiety (including obsessive-compulsive concerns and post-traumatic stress) through structured protocols. Within the Ontario Structured Psychotherapy Program, this position will provide high intensity psychotherapy services.

#### **Education and Qualifications:**

- Registered in the province of Ontario as a member in good standing with the appropriate College and eligible to provide psychotherapy as either a Registered Nurse, Social Worker, Occupational Therapist OR Registered Psychotherapist
- Master's degree is preferred
- Minimum 3 years of experience in the delivery of evidence-based CBT is preferred; documented evidence of CBT training with adequate supervision is preferred
- Demonstrated experience and knowledge of etiology and treatment of depressive and anxiety disorders as well as CBT and its application in mood and anxiety disorders
- Demonstrated experience and knowledge of the science and practices of psychotherapy including a full range of psychotherapeutic and assessment techniques
- Demonstrated experience and knowledge of diagnostic categories and criteria as listed in the Diagnostic and Statistical Manual of Mental Disorders (DSM-V)
- Results oriented work ethic to work independently and undertake tasks needed to accomplish work objectives and deliver quality, consistent and timely results
- Strong assessment skills to deliver and interpret symptom and outcome measures
- Demonstrated analytical, interpersonal, time management and organizational skills
- Proven written and verbal communication skills
- Proven ability to adapt readily to change
- Models and promotes core ethical practice, organization's values, and reflects an optimistic and positive attitude
- Proficiency in French/English language skills considered an asset
- Clear Criminal Record Check, including Vulnerable Sector Screen

- A valid Ontario G or G2 driver's license and a safe and reliable means of transportation. Travel throughout the district of Muskoka will be required.
- Experience and skills working with Indigenous people in First Nations community is an asset.

- Provide individual evidence-based CBT treatment through structured protocols
- Facilitate group Cognitive Behavioural Therapy (CBT) utilizing evidence-based approaches
- Participate in clinical consultation, meetings and training arranged through Waypoint Centre for Mental Health Care
- Maintain accurate and timely documentation and reports
- Collaborate with team members in provision of care and overall delivery of the OSP program
- Contribute to program development and program evaluation
